

## "INFORMATION ON CASH DEPOSIT TO SECURE THE PAYMENT OF EXCISE DUTY LIABILITY" form

We hereby inform the Revenue Department of the General Financial Office of the Financial Administration of the Republic of Slovenia (FURS) that on ..... **(date)** ..... **(personal or registered name of the payer)** from ..... **(place)** paid a cash deposit in the amount of EUR ..... to secure the payment of excise duty and the payment of interest which have arisen or may have arisen in connection with the payment of excise duty (hereinafter: excise duty liability) for excise products for which excise duty liability is incurred and secured in accordance with the Excise Duty Act (the ZTro-1; Official Gazette of the Republic of Slovenia [*Uradni list RS*], No. 47/16, 92/21 in 192/21) and the Rules on the implementation of the Excise Duty Act (Official Gazette of the Republic of Slovenia [*Uradni list RS*], No. 62/16, 67/16 – corrigendum, 62/18, 13/19, 108/21 and 71/22).

The cash deposit is paid to:

a) the **sub-account »FURS-DEPOZITNI PODRA.-ZAV.CAR.OBV.«**, No. SI56 0110 0695 5804 170, with the recipient reference SI21 PAYER'S TAX IDENTIFICATION NUMBER-550100nnnn<sup>1</sup>, if you are authorised excise warehousekeeper, exempt user, registered trader, excise duty representative, excise product importer, holder of a tax-free shop licence or to

b) the **sub-account »FURS-ZAVAROVANJE IZPOL.DAVČNE OBV.«**, No. SI56 0110 0600 0009 626, with the recipient reference SI21 PAYER'S TAX IDENTIFICATION NUMBER-55000-2900, if you are temporary registered trader (Article 59 ZTro-1), consignee receiving excise products from another Member State for commercial purposes (Article 29 ZTro-1), or person, who does not carry out a business activity and receiving excise products from another Member State (Article 30 ZTro-1).
